- We prohibit the export of hazardous electronic waste throughout the recycling chain in violation of the Basel Convention, Basel Amendments, OECD decisions and the laws of the importing, exporting and transiting countries.
- Used and end-of-life electronic equipment is triaged and processed based on a "reuse, recover, dispose" hierarchy of responsible management strategies. 2TRG takes all practical steps to direct properly functioning equipment and components to reuse unless a customer directs otherwise.

Worker Safety and Social Accountability



We are committed to educating our customers with regard to data security and privacy and we offer methods to ensure data is adequately destroyed.
